#### MINUTES

**Motion** made by S. Thompson, seconded by H. Grove to approve the meeting minutes of May 8, 2023. Passed: 6/0

#### **VILLAGE CLERK'S REPORT**

Motion made by H. Grove, seconded by J. Nicholson to pay bills. Passed: 6/0

Clerk Sprague asked the board if they would like to participate in the shirt sponsorship for the AFC High School sports program as we did last year. The board stated they would like to be a sponsor again this year.

# POLICE REPORT

(Chief Harney)

Complaints/Calls for Service – 11 Traffic Stops – 4 Traffic Arrest - 2 Traffic Warnings – 3 Criminal Arrest – 1 Ordinance Violations – 16 House Check – 2 Assist other Agency (Lee County) – 5

Trustee Nicholson inquired what the 16 ordinance violations were issued for. Chief Harney stated they were for weeds and grass. John stated he has a list of 19 properties that need attention – some are from the old list and some are new. Last week he asked BJ about the worst of the two properties, Currier's and Logan Jr.'s to see if he followed up by issuing warnings. John said BJ said he issued a warning to one but not the other. BJ stated he said he issued warnings to both. John said there was no indication there was a warning left. There was a Nicor shut off notice still at Currier's and if they took the ordinance violation you would think they would have taken the Nicor notice as well.

## **COMMITTEE REPORTS**

### **STREETS & ALLEYS**

(N. Sprague Chairman)

Trustee Nicholson informed the board the Lincoln Highway building will be offering sponsorship bricks for the south side of the building and inquired if they would qualify for the sidewalk reimbursement. President Atkinson stated he believes they would.

### WATER & SEWER

(A. Lanning Chairman)

Trustee Lanning informed the board of clarifier rehabilitation proposal came in at \$76,500. President Atkinson advised we should ask the Sanitation District for financial assistance with this repair.

**Motion** made by P. Erisman, seconded by S. Thompson to approve clarifier repairs for \$76,500. Passed: 6/0

#### **COMMUNITY DEVELOPMENT**

(H. Grove Chairman)

Trustee Grove informed the board the park committee is seeking village assistance in paying for fencing south of the shelter building to go around equipment geared for smaller children to make it safer. They are asking the village to pay for the fence and the park committee will pay for the labor. The park committee is meeting Wednesday and she will bring in estimated costs next month.

### PROPERTIES

(P. Erisman Chairman)

Trustee Erisman stated the shelter is 99% cleaned out and ready for the floor repairs. Paul stated there was a solar light on the sidewalk was knocked over and able to be fixed. One light is out and needs to be replaced. There is also a bad wire at the basketball court.

## (J. Nicholson Chairman)

Trustee Nicholson informed the board the Zoning board met today and unanimously voted to oppose the petition to construct a solar farm at the northeastern corner of Whitney Road and McGirr Road. The board agrees with the opposition and opted to sign a proclamation stating as such.

John Nicholson asked the board if they would approve of splitting the cost of a portable power distribution unit with Rooney's. Village portion would be around \$500. It was the decision of the board to implement a letter of agreement.
